### Invitation for Electronic Bids for the Security Printing, Supply and Delivery of Excise Stamps under International Competitive Bidding

1. Ministry of Finance, Inland Revenue Department, invites Electronic bids from all eligible bidders of Security Printers for the procurement of Security Printing, Supply and Delivery of Excise Stamps from all countries.
2. Bidding will be conducted through the International Competitive Bidding procedures specified in Government of Nepal, Public Procurement Act, 2007 and Public Procurement Regulations, 2008.
3. Interested eligible Bidders may obtain further information from the Inland Revenue Department and inspect the Bidding Documents at the address given below from 10.00 to 17.00 hours
4. Bidding documents is available online and can be downloaded from e-GP system: [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Interested bidders shall register in the e-GP system and deposit the cost of bidding document amounting a non-refundable fee of NRs 20,000.00 (In words : Twenty Thousand Nepalese Rupees) or USD 180.00 (In words : One hundred eighty United States Dollars) in the following bank:

5. Pre-bid meeting shall be held at the address below at 13:00 hours (NST), **November 8, 2020**
6. Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the above office of Inland Revenue Department, Lazimpat, Kathmandu, Nepal on or before **12:00 hours (NST), November 29, 2020**. Bid received after this deadline shall be rejected.
7. Bids shall be opened in presence of Bidders' representatives who choose to attend at **14:00 hours (NST), on November 29, 2020** at the office of Inland Revenue Department, Lazimpat, Kathmandu, Nepal. Bids must be valid for a period of 120 (One hundred twenty) days counting from the day of bid opening and must be accompanied by bid security or scanned copy of the bid security in *pdf format* in case of e-bid, minimum of amounting to **USD 400,000.00** (In Words: Four hundred thousand United States Dollars) or NPR 47,016,000.00 (In words: Forty-Seven Million Sixteen Thousad Nepalese Rupees), which shall be valid for minimum 30 days beyond the bid validity period (i.e. April 04, 2021) guaranteed by commercial Bank eligible to issue Bank Guarantee as per prevailing Law in Nepal.
8. If the last date of purchasing and /or submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. All the required documents for bidding process have been mentioned in bid documents. Hence, the bidders are requested to carefully examine those documents needed for the submission of the bid.
10. The Purchaser reserves the right to accept or reject all the bids without assigning any reason, whatsoever
